NEW YORK--(BUSINESS WIRE)--Jun. 10, 2021-- Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management ("AUM") as of May 31, 2021 totaled approximately \$278.6 billion. The month's AUM included market appreciation of \$3.4 billion, foreign exchange appreciation of \$1.9 billion and net outflows of \$1.1 billion.
