## Lazard Reports January 2022 Assets Under Management

NEW YORK--(BUSINESS WIRE)--Feb. 10, 2022-- Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management ("AUM") as of January 31, 2022 totaled approximately \$258.7 billion. The month's AUM included market depreciation of \$9.5 billion, net outflows of \$4.1 billion and foreign exchange depreciation of \$1.5 billion.
