Lazard Reports July 2022 Assets Under Management

NEW YORK--(BUSINESS WIRE)--Aug. 10, 2022-- Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of July 31, 2022 totaled approximately \$225.1 billion. The month’s AUM included market appreciation of \$9.8 billion, foreign exchange depreciation of \$1.0 billion, and net outflows of \$0.3 billion.
