## Lazard Reports May 2026 Assets Under Management

NEW YORK, June 10, 2026 /PRNewswire/ -- Lazard, Inc. (NYSE: LAZ) reported today that its preliminary assets under management ("AUM") as of May 31, 2026 totaled approximately \$284.8 billion. The month's AUM included market appreciation of \$11.6 billion, net outflows of \$1.4 billion and FX depreciation of \$0.7 billion.
