



Lazard Reports July 2026 Assets Under Management

NEW YORK, Aug. 12, 2026 /PRNewswire/ -- Lazard, Inc. (NYSE: LAZ) reported today that its preliminary assets under management ("AUM") as of July 31, 2026 totaled approximately \$286.9 billion. The month's AUM included market appreciation of \$1.5 billion, net inflows of \$0.4 billion and FX appreciation of \$0.4 billion.
