## LAZARD REPORTS DECEMBER 2020 ASSETS UNDER MANAGEMENT

NEW YORK, January 13, 2021 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of December 31, 2020 totaled approximately \$258.6 billion. The month’s AUM included market appreciation of \$7.7 billion, foreign exchange appreciation of \$2.9 billion and net inflows of \$0.4 billion. Preliminary average assets under management for the quarter ended December 31, 2020 were \$245.6 billion.
