- Additional Restricted Stock Units ("RSUs") were acquired pursuant to the dividend equivalent reinvestment provisions of underlying RSU awards.
- Each RSU represents a contingent right to receive one share of Class A Common Stock.
- Of these RSUs, 112 will vest on or around March 1, 2023, 113 will vest on or around March 1, 2024, 99 will vest on or around March 3, 2025 and 67 will vest on or around March 2, 2026.
