LAZARD REPORTS APRIL 2022 ASSETS UNDER MANAGEMENT

NEW YORK, May 11, 2022 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of April 30, 2022 totaled approximately \$236.6 billion. The month’s AUM included market depreciation of \$9.0 billion, foreign exchange depreciation of \$5.9 billion and net outflows of \$1.2 billion.
