LAZARD REPORTS DECEMBER 2022 ASSETS UNDER MANAGEMENT

NEW YORK, January 12, 2023 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of December 31, 2022 totaled approximately \$216.1 billion. The month’s AUM included market depreciation of \$5.7 billion, foreign exchange appreciation of \$2.9 billion and net outflows of \$2.1 billion. Preliminary average assets under management for the quarter ended December 31, 2022 were \$211.2 billion.
