LAZARD REPORTS SEPTEMBER 2022 ASSETS UNDER MANAGEMENT

NEW YORK, October 12, 2022 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management ("AUM") as of September 30, 2022 totaled approximately \$197.8 billion. The month's AUM included market depreciation of \$14.8 billion, foreign exchange depreciation of \$3.4 billion, and net outflows of \$1.0 billion. Preliminary average assets under management for the quarter ended September 30, 2022 were \$212.3 billion.
