Explanation of Responses:

- Pursuant to an amendment to the retirement policy governing the restricted stock units ("RSUs") of Lazard Ltd (the "Company"), the reporting person met the retirement requirements and is therefore eligible to receive restricted shares for the RSUs that were granted on February 11, 2010, including any additional RSUs received as dividend equivalents. The amendment provided that 45% of the reporting person's shares could be sold or withheld by the Company to pay applicable taxes and the remainder would be subject to certain restrictions on transfer, and covenants, in accordance with the underlying award.
- The shares of Class A common stock were acquired upon the conversion Restricted Stock Units.
- Shares withheld by the Company to cover estimated taxes.
- Each Restricted Stock Unit represented a contingent right to receive one share of Class A common stock of Lazard Ltd.
