## LAZARD REPORTS DECEMBER 2025 ASSETS UNDER MANAGEMENT

NEW YORK, January 13, 2026 – Lazard, Inc. (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of December 31, 2025 totaled approximately \$254.3 billion. The month’s AUM included market appreciation of \$2.2 billion, FX appreciation of \$1.5 billion and net outflows of \$0.3 billion. Preliminary average AUM for the quarter ended December 31, 2025 was \$261.1 billion.
