LAZARD REPORTS JUNE 2022 ASSETS UNDER MANAGEMENT

NEW YORK, July 13, 2022 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of June 30, 2022 totaled approximately \$216.6 billion. The month’s AUM included market depreciation of \$13.1 billion, foreign exchange depreciation of \$3.7 billion, and net outflows of \$2.5 billion. Preliminary average assets under management for the quarter ended June 30, 2022 were \$225.7 billion.
