## LAZARD REPORTS MARCH 2021 ASSETS UNDER MANAGEMENT

NEW YORK, April 13, 2021 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of March 31, 2021 totaled approximately \$264.9 billion. The month’s AUM included market appreciation of \$8.2 billion, net outflows of \$0.8 billion and foreign exchange depreciation of \$3.2 billion. Preliminary average assets under management for the quarter ended March 31, 2021 were \$261.5 billion.
