LAZARD REPORTS JULY 2020 ASSETS UNDER MANAGEMENT

NEW YORK, August 12, 2020 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of July 31, 2020 totaled approximately \$222.5 billion. The month’s AUM included market appreciation of \$4.5 billion, net outflows of \$1.4 billion and foreign exchange appreciation of \$4.7 billion.
