LAZARD REPORTS JULY 2019 ASSETS UNDER MANAGEMENT

NEW YORK, August 12, 2019 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of July 31, 2019 totaled approximately \$234.8 billion. The month’s AUM included market appreciation of \$1.5 billion; net outflows of \$2.0 billion; and foreign exchange depreciation of \$2.1 billion.
