## LAZARD REPORTS OCTOBER 2021 ASSETS UNDER MANAGEMENT

NEW YORK, November 10, 2021 – Lazard Ltd (NYSE: LAZ) reported today that its preliminary assets under management (“AUM”) as of October 31, 2021 totaled approximately \$279.7 billion. The month’s AUM included market appreciation of \$7.2 billion, net outflows of \$0.6 billion and foreign exchange appreciation of \$0.5 billion.
